Annual Drinking Water Quality Report

We are pleased to present to you this year's Annual Drinking Water Quality Report and results show that our drinking water meets or exceeds every health standard developed by both the U.S. Environmental Protection Agency (EPA) and the North Carolina Department of Environmental Quality (DEQ) for both the Iredell Water Corporation water system & Wayside Estates water system. We pride ourselves on providing our community with a reliable supply of safe and affordable drinking water.

The Iredell Water Corporation water system serves the communities of Union Grove, Harmony, Olin, Turnersburg, Central, Scotts Creek, Fairview, & Cool Springs. The Wayside Estates water system services the Wayside Estates Subdivision, Hwy 70, Bethesda Rd, Corn Flower Rd and Triplett Rd areas. Wayside Estates is owned and operated by Iredell Water Corporation. Both of these reports are snapshots of last year's water quality. Included are details about your source(s) of water, what it contains, and how it compares to standards set by regulatory agencies. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. What EPA Wants You to Know

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Contaminants that may be present in source water include microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses; organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems; and radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

The water that is used by this system is Ground Water and our 33 wells are located throughout our water system. We also have two interconnections for purchase water with the City of Statesville and Energy United Water Corporation.

Source Water Assessment Program (SWAP) Results

The North Carolina Department of Environmental Quality (DEQ), Public Water Supply (PWS) Section, Source Water Assessment Program (SWAP) conducted assessments for all drinking water sources across North Carolina. The purpose of the assessments was to determine the susceptibility of each drinking water source (well or surface water intake) to Potential Contaminant Sources (PCSs).
